# Notice Concerning Changes to Organization and Key Employees at Asset Management Company

Activia Properties Inc. (hereinafter referred to as the "Investment Corporation") announces that TLC Activia Investment Management Inc. (hereinafter referred to as the "Asset Manager"), to which Investment Corporation entrusts its asset management operations, decided to change its organization and key employees today, as follows.

#### 1. Change to organization

- (1) Detail of the change
  - i) Establishment of Asset Investment Department

To enhance the Asset Manager's organization in response to the Investment Corporation's external growth, the Asset Manager will set up an Asset Investment Department that will be responsible for acquiring and disposing of properties for the Investment Corporation. The present Asset Management Department will be divided into the Asset Investment Department and the Asset Management Department.

ii) Integration of Strategic Planning Department and Corporate Finance Department

To enhance its operational efficiency and internal management system, the Asset Manager will establish a Strategic Planning and Corporate Finance Department by integrating its Strategic Planning Department, which is responsible for the Asset Manager's corporate planning and serves as the point of contact for the competent authorities, and its Corporate Finance Department, which is responsible for its accounting and IT management.




