Change in Organization and Key Personnel at Asset Management Company

Ichigo REIT Management Co., Ltd. (the "Asset Management Company"), to which Ichigo Real Estate Investment Corporation ("Ichigo REIT") entrusts its asset management operations, approved at its Board of Directors meeting today the following key personnel changes.

- 1. Organization Change (effective November 1, 2011)
- 1) A Portfolio Management Department will be newly established in order to strengthen the management of the combined portfolio with the merger between Ichigo REIT and FC Residential Investment Corporation scheduled for November 1, 2011.
- 2) The Real Estate Group will be reconstituted as an Investment Management Group in order to foster comprehensive decisionmaking on investment and management of the full portfolio and all individual assets. The Investment Management Department will also be reorganized into a new Asset Investment Department.
- 3) The Finance Department will be divided into teams in order to establish more strict financial controls and delegate authority.


