Notice Concerning the Detail and the Conditions of the Investor Benefit Program for the fiscal year 2013

With respect to the Investor Benefit Program for the fiscal year 2013 announced on May 23, 2012 (hereinafter called "Program"), Japan Hotel REIT Investment Corporation (hereinafter called "JHR") informs you of its detail and the conditions as follows:

1. Program Criteria

Eligible investment unit holder

As of June 30, 2013 (base date), the investment unit holder who holds <u>ten or more</u> JHR units and whose name is on JHR's Investors' Registry.

In Tokyo Stock Exchange, June 25, 2013 will be the last trading day of the investment units that will be benefited from this program.

Detail

2. Validity, Detail, and Conditions of the Program and Points to Remember

Validity

Detail and conditions of the complimentary coupons for accommodation

- The eligible investment unit holder will be able to reserve all types of guest rooms with the complimentary coupons excluding "Alivila Suite" and "Royal Suite" of Hotel Nikko Alivila, and the regular rack rate will be discounted by 50%.

Detail and conditions of the complimentary coupons for restaurants
