Notice Concerning Partial Modification of Asset Management Contract

This is to inform you that Japan Hotel REIT Investment Corporation (hereinafter called "JHR") has resolved to modify the asset management contract concluded between JHR and its asset management company, Japan Hotel REIT Advisors Co., Ltd. (hereinafter called "JHRA"), dated November 10, 2005 (hereinafter called "Contract" including subsequent modifications) today as below.

Modification below will be effective upon approval of the agenda in relation to partial modification of Articles of Incorporation of JHR at 6th Investors' Meeting of JHR to be held on November 28, 2013.

1. Rationale for modifying the Contract

The Contract must be consistent with the modified Articles of Incorporation in relation to 2 below. Please see our press release "Notice Concerning Modification of Articles of Incorporation and Appointment of Directors (Summary)" dated October 24, 2013 for detail of modification.

- 2. Modification detail of the Contract
 - (1) Modification in relation to the regulation that enables JHR to acquire its own investment units. (*1).
 - (*1) The above modification will be effective when revised Act on Investment Trusts and Investment Corporations comes into force and JHR will be able to acquire its own investment unit for profit by the mutual agreement between JHR and investors. As of today, JHR has no plan to acquire its own investment unit.
 - (2) Modification of management fee system due to the following A, B, and C. (*2)
 - A. Management fee 1: Review of the present percentage of management fee.
 - B. Management fee 3: In order to establish management fee system through which JHR will be able to pay more attention to the investors' benefit, JHR will introduce management fee that links with dividend per unit and appoint a new time of payment.
 - C. Modification of scope of the major investment target assets based on which management fee is computed.

- (3) Modification of wordings and update of the numbers of articles and clauses where necessary.
